On behalf of the DBIA-WPR Board of Directors, we invite DBIA members in good standing to submit nominations for the 2013 Board of Directors. We are seeking candidates who understand and support DBIA's mission and goals and who are committed to advancing the understanding and use of design-build project delivery across all sectors and markets.

When reviewing candidates, the Nomination Committee of the Board will consider, among other things, the following:

- Previous service to and support of DBIA by the nominee or his/her organization.
- The nominee's availability for up to two face-to-face meetings per year and attendance at the Strategic Planning Meeting (with the exception of public owners, Board members are responsible for their own travel costs).
- The DBIA certification credential is preferred, though not required.

Due to the diverse nature of DBIA's member base, individuals representing all type of organizations, including public and private owners, are encouraged to apply.

The nomination must include the following information:

- Your full name and company name.
- Why you are interested in serving on the DBIA-WPR Board.
- A brief letter confirming your willingness to attend up to four Board meetings per year without travel reimbursement (with the exception of public owners) and confirming your commitment to DBIA's mission and strategic goals.
- The names and contact information of at least two DBIA members who "second" the nomination.

Nominations timeline:

- October 1, 2012: Nominations due to DBIA-WPR.
- October 8: Candidates notified of recommendations to Board by Nomination Committee.
- October 11: Nomination Committee provides recommendation to Board.
- October 25: Notice of slate to regional membership via email.
- November 29: Floor nominations and election.
- November 29: New Board members installed at DBIA-WPR Annual Meeting.
